OBJECTIVES AND RESULTS OF THE PROJECT

• Create a bridge between generations on the central theme of fundamental and universal rights

At least 10 schools and at least 30 seniors will be involved in activities promoting and raising awareness on the theme of the project. The participation of 1000 teachers and 2000 children is expected

• Stimulate the elderly to resume an active role in society as promoters and defenders of fundamental rights





30 seniors will be trained at European and national level. Besides them, the project wants to involve 200 elderly people at the local level

• To train the elderly in the areas of defense of human rights, craftsmanship and education

The 30 adults involved in the training will be trained specifically on issues related to human rights, on the production of handcrafted fairy tales (used for activities in schools) and on teaching techniques and children's involvement.

• Raise awareness among the younger generations on the importance of defending their rights and those of society as a whole

The actions promoted by the elderly within the schools involved will fall on a minimum of 2000 children. The fairy tales will then be "released" in the libraries to be exchanged together with the project's handbook

• Involvement of institutions:

Through dissemination and awareness-raising activities, around 15 public bodies, institutions, associations and organizations and 10 libraries will be involved in order to extend to the community where the schools are located and the partners are active in the defense and promotion of fundamental rights.

OUTPUTS:

The first three outputs are the three pillars of the project, the three manuals that will guide the implementation of the project. The rights we will speak about, the tool we are going to use (the cases) and how to work with the children in class.

O1 HANDBOOK Talking about human rights through fairy tales [leader ARID]

Manual about the rights: their value, fights and threats, participation, etc A participatory work with the seniors to create guidelines to read the tales under a certain point of view.

The work will start from well known (fairy)tales and in the story will be identified the cues to speak about endangered fundamental human rights. Once identified the rights, the partners will involve the seniors to collect information about the national history of these rights, because the fights have been different from country to country. Three tales will be analysed in deep: Pinocchio, Don Quixote and a third one that will be selected after the meeting. Other tales and will be collected and just listed for future uses.

The Output will be translated in all the partners' language and uploaded online

O2 How to build the suitcases of fairy tales [leader Europole]

Manual and video on how fairy tales are made in the suitcase and how the main values of the society can be transmitted with them.

The videos will be produced before or during the training. If the partners need it Europole can provide them a case of fairy tales as an example to be showed to the seniors.

O3 How to manage non formal educational activities in class [leader PRSC]





Experts and teachers provide advice and hints to engage the children: communication tools, the language to use, the contents to be mediated and above all how to stimulate a discussion on fairy tales and the themes (the rights) contained in them.

O6 Fairy-tales of rights in a suitcase [Leader Europole]

The real suitcases with the fairy tales of rights that should be distributed to the libraries, schools and cultural centres.

O7 RIGHTS - Fairy-tales of rights in a suitcase: a bridge between the generations [Leader JCYL]

A manual that accompanies the suitcases of tales that will be given to the school and the libraries. It may include the entire process of training and project implementation, the challenges, the potential and the lessons learned in the implementation.

JCYL has already provided an Index. A part about the practical use of the suitcases needs to be added.
